# **RECIPE FOR HEALTH**

### TURKEY MEATLOAF

Turkey is a drier meat because it does not have a lot of fat. Be sure and grease you pan before baking so it does not stick. Bake at 375 degrees for 1 hour





2 lbs Ground Turkey

3/4 cup crushed buttery round crackers

- 2/3 cup milk
- 2 small onions chopped

1 Bell Pepper – chopped – if desired

- 2 eggs
- 2 packages Meatloaf Seasoning (brand of choice) 1clove garlic, minced
- 1 ½ tsp ground black pepper

\*\*\*\* Can also add 1 cup cheddar cheese to mixture

TOPPING – **Add the last 15 minutes of baking** 1 cup ketchup 1/2 cup brown sugar 1Tblsp Worcestershire sauce

For a crunchy topping add cheese to the mixture, bake until topping becomes brown – Cheese will not melt
