#### PREPARING FOR YOUR FUTURE

Since the first of the year we have been talking, in our meetings, about various aspects of preparing for the future. No matter how healthy we feel, how prepared we "know" we are something can happen to throw everything out of balance. Suddenly you or your love one is left unable to care for yourself or unable to take care of business for you. It is a job that no one wants to think about but eventually it will come to be.

I have taking the "Google walk" and researched information on estate planning and preparation. I am including some of that information in the newsletter. This will give you a starting point but do the "Google walk" yourself and do your own research or touch base with community advocacy programs in your area for information.

One step for the present is to make sure your paperwork is together and you have some identified to speak and act for you.

1. How does that person get authority to speak and act for you? Two options are available.

#### a. Power of Attorney

- A Power of Attorney grants to someone else called the agent, attorney-in-fact, or surrogate -- the right to make legally-binding decisions for the person who grants that authority. This is true for a power of attorney for health care and for a power of attorney for finances. A power of attorney may be limited to certain decisions only, or to a specific time period, or it may be open-ended.
- It can be revoked at any time by the person granting it.
- Its authority ends if and when the person granting the authority becomes incapable of making his
  or her own decisions.

#### b. Durable Power of Attorney

- A Durable Power of Attorney remains valid and in effect even if you become incapacitated and unable to make decisions for yourself.
- For people who want to make sure that their wishes about end-of-life medical care are followed, and who want their financial matters handled in a particular way after they can no longer make decisions, they must specifically state in their power-of-attorney documents that the authority granted is "durable."
- 2. Estate Planning Will or a Trust here again you need to pick the one that best suits your needs. There is a difference in both of these documents as well.
  - a. WILL goes into effect ONLY after you die
    - Directs who will receive your property at your death and it appoints a legal representative to carry out your wishes
    - A will passes through probate. That means a court oversees the administration of the will and ensures the will is valid and the property gets distributed the way the deceased wanted
    - A will becomes public record
  - b. TRUST Takes effect as soon as you create it
    - Can be used to begin distributing property before death, at death or afterwards
    - Is a legal arrangement through which a "Trustee" indentified by the individual, holds legal title to property for another person, called a "beneficiary."
    - Usually has two types of beneficiaries -- one set that receives income from the trust during their lives and another set that receives whatever is left over after the first set of beneficiaries dies.
    - A trust can be used to plan for disability or to provide savings on taxes
    - A trust passes outside of probate, so a court does not need to oversee the process, which can save time and money
    - A trust can remain private

#### RECIPE FOR HEALTHY EATING

Have you ever thought about what you can do with a tortilla? A Taco! Of course a taco. Have you ever thought about how many type of tacos you can make. Too many to think about. Here's a few ideas for summer fun, avoiding the heat wave in the kitchen and a 30 minute or less meal that means you can enjoy the rest of day just being leisurely lazy.







Tortilla options are your choice, corn, flour, wheat and more.

**The standard** – Chicken, Beef - ground or shredded, fish, shrimp – season to your taste. Dress with your favorite – lettuce, tomato, avocado, salsa, cabbage, white sauce, sour cream and cheese. You be the designer.

Guaco-Taco - Guacamole, beans, home-made salsa combine to make a light, flavorful alternative to traditional tacos.

  systems within the county. Any hospital would be able to pull up records on patients from

- Advance Health Care Directive not an order TOOL helps to make decision
- POLST Physician's Order for Life Sustaining Treatment -MSA-111B current date is on top left corner
- End of Life Option Act Effective 6/9/2016 Specific who can utilize this. Cannot have Dementia. Can decide their own death. Must be able to take the capsule themselves.
- Hospice prolongs life does not induce death. Patient lives an average of 18 months longer on Hospice care
- Hospice works with Primary Care doctor
- Keep in own environment and teaching them about their illness and how to deal with it
- 6 months or less
- Hospice covered reverts back to Medicare benefits VA reverts back to Hospice for care as they don't have their own
- HIPPA laws Over the age of 18, no Advance Health Care Directive. Sign a release form at

## EMERGENCY MEDICAL SERVICES PREHOSPITAL DO NOT RESUSCITATE (DNR) FORM



#### PURPOSE

The Prehospital Do Not Resuscitate (DNR) Form has been developed by the California Emergency Medical Services Authority, in concert with the California Medical Association and emergency medical services (EMS) providers, for the purpose of instructing EMS personnel regarding a patient's decision to forego resuscitative measures in the event of cardiopulmonary arrest. Resuscitative measures to be withheld include chest compressions, assisted ventilation, endotracheal intubation, defibrillation, and cardiotonic drugs. This form does **not** affect the provision of life sustaining measures such as artificial nutrition or hydration or the provision of other emergency medical care, such as palliative treatment for pain, dyspnea, major hemorrhage, or other medical conditions.

#### **APPLICABILITY**

This form was designed for use in **prehospital settings** --i.e., in a patient's home, in a long-term care facility, during transport to or from a health care facility, and in other locations outside acute care hospitals. However, hospitals are encouraged to honor the form when a patient is transported to an emergency room. California law protects any health care provider (including emergency response personnel) who honors a properly completed request regarding resuscitative measures, including a Prehospital Do Not Resuscitate Form (or an approved wrist or neck medallion), from criminal prosecution, civil liability, discipline for unprofessional conduct, administrative sanction, or any other sanction, if the provider believes in good faith that the action or decision is consistent with the law and the provider has no knowledge that the action or decision would be inconsistent with a health care decision that the individual signing the request would have made on his or her own behalf under like circumstances. This form does not replace other DNR orders that may be required pursuant to a health care facility's own policies and procedures governing resuscitation attempts by facility personnel. Patients should be advised that their prehospital DNR instruction may not be honored in other states or jurisdictions.

#### Instructions

The Prehospital Do Not Resuscitate (DNR) Form **must** be signed by the patient or by the patient's legally recognized health care decisionmaker if the patient is unable to make or communicate informed health care decisions. The legally recognized health care decisionmaker should be the patient's legal representative, such as a health care agent as designated in a power of attorney for health care, a court-appointed conservator, or a spouse or other family member if one exists. The patient's physician **must** also sign the form, affirming that the patient/legally recognized health care decisionmaker has given informed consent to the DNR instruction.

The white copy of the form should be retained by the patient. The completed form (or the approved wrist or neck medallion—see below) must be readily available to EMS personnel in order for the DNR instruction to be honored. Resuscitation attempts may be initiated until the form (or medallion) is presented and the identity of the patient is confirmed.

The goldenrod copy of the form should be retained by the physician and made part of the patient's permanent medical record.

The **pink** copy of the form may be used by the patient to order an optional wrist or neck medallion inscribed with the words "DO NOT RESUSCITATE-EMS." The Medic Alert Foundation (1(888)755-1448, 2323 Colorado Avenue, Turlock, CA 95381) is an EMS Authority-approved supplier of the medallions, which will be issued only upon receipt of a properly completed Prehospital Do Not Resuscitate (DNR) Form (together with an enrollment form and the appropriate fee). Although optional, use of a wrist or neck medallion facilitates prompt identification of the patient, avoids the problem of lost or misplaced forms, and is strongly encouraged.

#### REVOCATION

In the absence of knowledge to the contrary, a health care provider may presume that a request regarding resuscitative measures is valid and unrevoked. Thus, if a decision is made to revoke the DNR instruction, the patient's physician should be notified immediately and all copies of the form should be destroyed, including any copies on file with the Medic Alert Foundation or other EMS Authority-approved supplier. Medallions and associated wallet cards should also be destroyed or returned to the supplier.

Questions about implementation of the Prehospital Do Not Resuscitate (DNR) Form should be directed to the local EMS agency.
