Guest Speaker

Merilee Colton, CSR Membership Chair - statewide

Merilee shared with the group some brochures and blue cards used to sign members. She encouraged everybody present to use these aids to enlist future retirees. She asked the group to use the blue card, ask the future member to sign it and be the person responsible for mailing it. This way we are sure the card does not get lost. Marilee also provided a short history of CSEA:

- Approximately 95 year ago a group of CSEA members requested the Governor to implement a defined retirement system for civil servants in CA. The proposal was promptly rejected.
- > 1926 the Civil Service Committee was created
- > 1927 the Civil Service Committee (CSC) 2nd requested the Governor to implement a defined retirement system
- > 1929 Constitutional Amendment to create the defined retirement system
- > 1930 ballot initiative regarding the defined retirement system
- > 1931Governor signed into law the defined retirement system
- 1960 Merit System for Employment enacted
- > 1970 Dills Act -Collective Bargaining Act was enacted

Our defined benefit system is under attack on the ballot box and in the Courts. The CA Supreme Court is expected to rule regarding a lawsuit brought by several Ca Counties against the "California Rule." The California Rule protects our pensions – once you sign a contract with the State - your pension and benefits are sacrosanct. The Court is being asked to abolish the CA Rule which could lead to pension cuts retroactive.
