PRESIDENT'S MESSAGE

I hope everyone has enjoyed a rather unusual Spring and looking forward to a terrific summer. My first activity as a new president was to attend the CSR Strategic Plan meeting that was attended by CSR Board members, chapter presidents and the committee chairs to continue to advance the organization's strategic planning and action planning process.

The final, board adopted strategic plan for CSR was shared. They will send the strategic plan along with "frequently asked questions", to the chapter presidents within the next

month so we can share these documents with members. The strategic plan will be available at our August meeting.

A couple of draft documents were distributed. The first delineates roles and responsibilities with regard to implementing Goal 2: Build and Retain Membership. This document will be refined based on the feedback of the attendees.

The second draft was about committee principles, which clarifies the role of the committees, committee chairs, and the Board's relationship to the committees.

As part of the strategic planning process, chapter presidents completed a chapter assessment survey to help the Board understand the chapters' current practices and capacities.

It was a very full day and I look forward to sharing the strategic plan with Chapter 17 members.

On June 27 there were the committee meetings. The Political Action Committee provided a list of candidates that support CSR issues. Please review the California State Retiree or talk with Laurie Bella, Chapter 17 member who sits on this committee.

The Health Benefit Committee Chair gave a report on open enrollment. The CalPERS Board decided to eliminate risk adjustment which the premiums lower for the PERSCare plan. Although CalPERS used some excess surplus to reduce the cost the basic plan costs greatly exceed the State's contribution. Retirees on Medicare who are receiving the full State contribution will be fine. The retirees who are on the Basic and Combination plans will be affected by the increase.

Our retirees in the Imperial Valley on the basic plans will experience increases in PERSCare with a 19,8 percent increase, Anthem Blue Cross Traditional HMO with 22.96 % increase and Blue Shield Access+HMO with a 6.21% increase. Everyone please review your open enrollment information carefully. The new rates are on the CalPERS website, as well as, the new state contribution rates.

I will be working with CalPERS to have Health Fairs in our area.

Optum RX to be guest at August 2, 2018 – Chapter Meeting

Guest Speaker is Christina Fountain, OptumRX accompanied by pharmacist, Ben Chun.

Your opportunity is here to get your questions answered with regards to OptumRX and your prescription coverage. Bring examples of problems, discuss and get a resolution. Optum is working very hard to resolve issues as they come up. If you are having problems let them know what they are so they can get them taken care of.

With open enrollment beginning September 10th now is the time to gather as much information as you can on the new plans, costs, availability, etc. We will have as much information as we can available at this meeting.

As mentioned in the President's report – there will be an increase in rates so take a good look. Our Imperial Valley members need to review and ask the questions to be able to make your decisions.

Guest Speaker Margaret Brown, CalPERS Board Member

Garden Grove Unified School District – works in construction. Supported only by CSR, RPEA and JJ. Has had public battles with CalPERS just to get her mail delivered and to received meeting's transcripts. She will continue to publicly fight the board when the board does not play by the established rules Ms. Brown is trying to teach the board that they can't change the rules in mid-play.

Long Term Care – closed session, in litigation. Attorney website. It is Margaret Brown's opinion that CalPERS is trying to stall.

Chief Investment Officer (CIF) – did not – under performed their benchmark. CalPERS has proposed to change the way they do private equity investment. The new plan is to buy up everything then sell them off or keep them. But instead of having staff (investment officers) doing the buying/selling, the CIO proposed to hire another company to do the investments. This middle company will have their own board of directors and would not be responsible to the CalPERS board. Thus, CalPERS will lose control over its investments. Presently, CalPERS is getting rid of a lot of the current investment officers.

Ms. Brown has requested a copy of CalPERS budget report, but to date she has not received it. In her opinion, CalPERS needs to do a better job in investing.

Elections this year. Theresa Taylor – Rob Fecknor – no one ran against them. Priya is being challenged by Jason Perez from the California Highway Patrol.

Pension and health benefits. Health insurance rates will be higher next year. The CalPERS Health Committee is looking for as many solutions as possible. Rural areas are problematic.
